Extension of Amnesty Applications

Further Extension of the Deadline for Amnesty Applications

Deadline of all amnesty applications is further extended until **NOVEMBER 6, 2023**.

The period from <u>November 7, 2023 to December 4, 2023</u> shall only be dedicated to the submission of supporting reportorial documents for all applications.

Amnesty Microsite

The SEC put up an amnesty microsite at https://amnesty.sec.gov.ph to provide updated information and relevant materials and to guide applicants through the process.

Procedure

Filing of Amnesty Application. Eligible corporations may submit an Expression of Interest (EOI) through eFAST <u>until November 6, 2023</u>. The EOI is a web-based form integrated in the eFAST and downloading/manually accomplishing the form is no longer needed.

Submission of Reportorial Requirements. Non-compliant corporations which shall have uploaded and submitted the correct reportorial requirements (*i.e.* latest GIS and AFS), including those reverted for compliance, within the submission period or <u>until December 4</u>, <u>2023</u> shall be considered to have completed the amnesty application process and is entitled to a Confirmation of Payment ("COP") downloadable via eFAST.

In case of corporations whose Certificates of Incorporation ("COI") have been suspended or revoked, their respective Petitions to Lift Order or Suspension/Revocation shall be uploaded and submitted along with their latest due GIS and AFS within the submission period or <u>until December 4, 2023</u>. In addition, these corporations shall submit the following requirements in support of their respective petitions <u>not later than December 4, 2023</u>:

- 1. Directors' or Trustees' Certificate;
- 2. Latest due AFS, as received by the SEC and BIR;
- 3. Latest due GIS, as received by the SEC;
- 4. Copies of COI and latest Certificate of filing of Amended Articles or By-laws, if any, together with the latest Articles of Incorporation and By-laws;

- 5. Copy of registration of stock and transfer book or membership book;
- 6. Secretary's Certificate of No Intra Corporate Controversy;
- 7. Sworn Certification by the External Auditor;
- 8. Proof of ongoing operation, such as but not limited to:
 - AFS;
 - ITR;
 - Mayor's or Business Permits;
 - Contracts;
 - Receipts showing payment of Real Estate Tax;
 - Certification/Recognitions/Annual Conventions; or
 - Any similar/related documents.
- 9. Latest Mayor's/Business Permit;
- 10. BIR Certificate of Registration
- 11. Certification from the Corporate Secretary that the Latest Financial Statement and Income Tax Return was received by the SEC and BIR, respectively; and
- 12. Compliance with SEC Memorandum Circular No. 28, Series of 2020.

Forfeiture of Amnesty Fees. Failure to submit the complete set of requirements within the prescribed periods shall result in the forfeiture of:

Amnesty fee of Php5,000.00	For non-compliance corporations
50% of total assessed penalties	For suspended/revoked corporations
Initial petition fee of Php3,060.00	

Refund of Overpayment. Except in highly meritorious cases, refund of amnesty fee for non-compliant corporations shall not be accommodated.

Updated Scale of Fines and Penalties

The updated scale of fines and penalties for the covered reportorial requirements shall be implemented on November 7, 2023.
