EXTENSION OF THE DEADLINE FOR THE FILING OF POSITION PAPERS, REPLIES, PROTESTS, DOCUMENTS AND OTHER SIMILAR LETTERS AND CORRESPONDENCES IN RELATION TO ONGOING BIR AUDIT INVESTIGATIONS, AND FILING OF VAT REFUND WITH VAT CREDIT AUDIT DIVISION

Covered Taxpayers

- Taxpayers registered with RDOs in NCR Plus Areas (Metro Manila, Laguna, Cavite, Bulacan, and Rizal); and
- Taxpayers outside NCR Plus who have transactions with any BIR office within NCR Plus.

Extension of Deadlines

The deadlines for filing of the following letters and documents falling due on April 5, 2021 and during the ECQ Period, including extensions thereof, are extended as follows:
